## The Great Hunt: Return of the Burning Times

This horrific period gave us the "witch hunt" as a

Today we consider it ridiculous that people once believed human beings possessed supernatural powers and should therefore be burned alive, hung, or broken on a wheel to destroy the devil within. But, demonic possession was once a deeply held belief that spread throughout Europe from Italy to Scandinavia. According to recent scholarship, 40,000 to 60,000 people alleged to practice witchcraft were put to death—the majority between approximately 1550 and 1650, in what historians call the Great Hunt, or the Burning Times.\*

In that era, fantastic ideas were put forth to justify belief in the irrational. When the suspected witches of old had airtight alibis, ways were invented to get around them. An accused witch's spouse might testify that she had been sleeping soundly beside him all night in bed, but she could still be found guilty of going abroad in the dark to perform diabolic deeds. This was explained by the idea that a person's spirit could leave her body and take the form of an animal, or a doppleganger (her double or evil twin) and thus she could be in two places at once. The image of witches on broomsticks traversing the night sky was borne of the idea that spirits were leaving their bodies and going off to participate in devil worship, or black sabbaths.

metaphor to describe a frenzied search for perceived enemies, with little regard to their actual guilt or innocence. However, today's politically motivated hunts are no longer predicated on the fear that people actually possess supernatural powers—or are they? The modern mentality no longer holds such irrational beliefs as demonic possession—or does it? It might be worth reflecting on some characteristics of that era when we think about what's happening today—characteristics such as:

**Demonology.** The Great Hunt of contemporary times was initiated by U.S. authority and is accompanied by the rising power of NATO. It takes on various forms with the whole world as hunting grounds: there are fishing expeditions to identify domestic enemies, hunts to apprehend undocumented people and suspected terrorists, and hunts for declared enemies in other countries.

A declared enemy in another country often takes the form of an "evil dictator," characterized by possessing such enormous capacity for evil that his power and reach is super-human, far beyond that of mortal men. These dictators are portrayed as able to threaten the best equipped military in the world. It's an oft-repeated mantra that these leaders are "killing their own people." While it's only realistic to acknowledge that some heads of nations do deal harshly with domestic enemies, reports can also be embellished to contribute to a demonic image. Some foreign leaders have even been alleged to perform actions akin to the rituals said to have been observed at witch's sabbathskilling babies and conducting sexual orgies. In 1991, the 15-year-old daughter of the Kuwaiti ambassador to the U.S. testified that Saddam Hussein's soldiers were dumping babies out of incubators, something that was later proved to be

blatantly false. Muammar Gaddafi was reported to have ordered Viagra for his soldiers so that they could supposedly rape the women of Libya, while simultaneously defending their country and themselves against 20,000 NATO sorties.

We are told that the only way to stop these "evil doers" is by "hunting them down" and murdering them in cold blood as was done to witches of old, destroying their tremendous power ("cutting off the head of the snake"). Among those leaders described as diabolic are the late Sadaam Hussein, the late Osama bin Laden, Kim Jong-il, Mahmoud Ahmadinejad, and Muammar Gaddafi, and to a lesser extent Hugo Chavez and Fidel Castro, who both have escaped multiple assassination attempts. Groups are also described as possessing super-human evil traits: Hamas, Hezbollah, the FARC, the Taliban, Al Qaeda and more recently, Al-Shabaad in Somalia. Evil seems to dwell especially in geographic regions where the U.S. and NATO have "interests." (Ironically, some of these leaders or groups were originally given or sold weapons and empowered by the U.S. And, in some cases, the U.S. policy of military aggression has been creating more real enemies with potential for blowback, though not on the scale of U.S. military.)

Today, those identified as enemies are hunted with bullets, aerial bombings and unmanned drones. Drone operators in the U.S. refer to targets they site on their scopes, from thousands of miles away, as "scorchers" when they are instantly incinerated by Hellfire missiles. The wicked ones are to be stopped by any means necessary, even if that entails killing innocent people in the process. Hundreds, thousands, even more than a million people have been killed in foreign countries—supposedly to stop these evil dictators and groups. This rationale is reminiscent of the belief that it was better to kill many innocent people than let one witch escape— "Kill them all and let God sort them out."

Unfair trials, military tribunals, torture, and imprisonment of political enemies are other contemporary practices for dealing with super-human evil. Innocent until proven guilty does not apply.

Satanic forces: Witches of old were thought to be at the command of Satan. While controlling financial entities plunge today's world into global crisis, the fear of some economic systems is so great that such systems are demonized communism with its shared resources, socialism with its public ownership, and Islam, which is both a religious and economic system, with laws that include the forgiveness of debt and prohibition of usury (a great inconvenience for the World Bank and the IMF).

**Fear mongering:** In the Burning Times, allegations of witchcraft were supported by the elite in secular society and institutionalized in secular courts, conveniently serving as a means to control the population. But common people often initiated the persecution of alleged witches. Anyone stepping out of line could be under suspicion. The Great Hunt today is dependent on inculcating the U.S. populace with a belief that we must live in constant fear of evil forces. Recently, it was even reported that we should be concerned that our neighbor on the block could actually be a "lone wolf terrorist," an image evocative of a werewolf. It's the business of corporate media, Fox News, and Clear Channel radio to generate fears like this.

**Vulnerability of victims:** In the Burning Times, men were also accused of witchcraft, but 75-80% of people accused of witchcraft were women. Vulnerability increased the possibility of being targeted. Today, people from the Middle East and Somalia, people of color, dissidents, antiwar and union organizers, peace activists, international solidarity activists—those who object to U.S. foreign policy—have been targeted for their beliefs. Most of the people recently subpoenaed to appear at a federal grand jury investigation of "material support for terrorism" were women in the Midwest. Two Somali women, naturalized American citizens from Rochester, Minnesota, are currently facing trial in a U.S. district federal court with this accusation.

Much of the hunting in the Burning Times took place in border regions between nation states. Today, the southern border of the United States is a main focus for hunting undocumented Latinos. In Maricopa County, Arizona, a notorious sheriff even boasts of a partnership with local citizens to hunt down the undocumented.

Teachers and nurses and their unions, welfare recipients, Social Security and Medicare recipients aren't blamed for crop failure or a cow dying, but they were blamed for the country's economic woes. Although there are certainly men in all of these categories, the majority are women.

Kill lists: In the twenty-first century, the executive branch has expanded the hunt to include killing unarmed people without trial. Supposedly, Navy Seals killed Osama bin Laden in a house in Pakistan. And now even American citizens living abroad can be killed without a trial. Most recently the cleric Anwar al-Awlaki was hunted and killed in Yemen, not for actual acts but for "inspiring acts." Also, killed was another American citizen, Samar Khan, the editor of an internet publication, who was said to be influencing un-American acts. Many of those accused of witchery in the past centuries were at least given trials.

**Torture:** In the Burning Times, suspected witches were often tortured in attempts to extract confessions. In the contemporary world, torture has been used for the same purpose. But, it is just as irrational to expect anything but a confession of guilt because it is well known that people will confess to anything when tortured. Torture is used to create evidence that isn't there.

Hunters with economic and career motives: Witch hunting was an occupation with a monetary reward during the Great Hunt. In July of 2010 in an investigative series for the *Washington Post*, Dana Priest and William Arkin reported that, after 9/11 "some 1,271 government organizations and 1,931 private companies work on programs related to counterterrorism, homeland security and intelligence in about 10,000 locations across the United States." This means thousands of careers and jobs, in both public and private sectors, are dependent on producing results, and that means the hunt is greatly expanding. The weapons industry and related war profiteers have overarching economic motives, as well.

Removal of people for gain: While people actually believed in witchcraft during the Burning Times, there were also times when real power struggles and land issues were involved. Some historians have concluded that societal instability was a factor in Europe: Most of the executions occurred

in central Europe: in the German states, the Swiss Federation, parts of France, and in border regions between nation states during the Reformation when there were power struggles between Catholicism and Protestantism. Today, the U.S. and its allies conduct hunts on foreign soil to capture land, resources and power. Eliminating defenders of the land allows the land and its resources to fall into the hands of occupiers or prevents other powers from gaining access. Those who try to defend a geographic area, its people and resources are considered evil and enemies. Those in sympathy with the defenders may also be considered suspect and are sometimes persecuted.

When will it end? The Great Hunt in Europe finally was nearly over at the end of the seventeenth century. When will the Great Hunt of this era end? The people's occupations taking place in public squares are a hopeful sign.

We must put a stop to the insanity of our day before more of our fellow human beings here and around the world are incarcerated, or incinerated. While people in other countries are burned alive from Hellfire missiles and white phosphorous, protesters here may risk temporary trauma from having their eyes burned with pepper spray. But allowing the Burning Times of our era to continue is far more risky.

### **Being Smart about ALEC**

What Is ALEC? The American Legislative Exchange Council (ALEC.org) comprises not only legislators but "members of the private sector who share ALEC's mission." Its mission? "To advance the Jeffersonian principles of free markets, limited government, federalism, and individual liberty."

What's wrong with that? There may be clues in ALEC's self-descriptions, its constituencies, and the ways the organization works.

ALEC's function is to write, or rewrite, legislation and facilitate passing certain "model bills" that have far-reaching effects on many aspects of people's lives and have, as well, many benefits to certain corporations' bottom lines. Corporate executives appear to be the driving force in ALEC's shaping of public policy. Behind closed doors, corporate representatives give state legislators changes they desire to laws and members "vote" on changes to be brought to state legislatures. That's why similar bills are introduced into the legislature of all 50 states.

A list of the policy areas in ALEC's sights shows how comprehensive the policy interests are: Nine task forces serve as the "laboratories" where public policies are developed and shaped. Each task force has a chair from the public and the private sector, and corporations are well represented on every committee. The task forces are:

- Civil Justice
- Health and Human Services
- Commerce, Insurance, and Economic Development (A street sign, "WALL ST" is superimposed on the image for this link.)
- · Education; Energy, Environment, and Agriculture
- Telecommunications and Information Technology
- Tax and Fiscal Policy
- the oddly conjoined Public Safety and Elections (the background on this link is a yellow CRIME SCENE barrier tape).
- International Relations. With uncommon candor and/or arrogance, the organization states that the members of the International Relations Task Force assert "the power of free markets and limited government to propel economic growth not just in the United States but around the globe."

Who Are These People? ALEC says that it's non-partisan. You can judge that for yourself. Alumni include John Boehner, Eric Cantor, Congressman Joe Wilson (the infamous shouter who called the President a "liar" during the State of the Union address), former House Speaker Dennis Hastert, former House Speaker Tom DeLay, Andrew Card, Donald Rumsfeld (1985 chair of ALEC's Business Policy Board), Governor Scott Walker, and more (www.alecexposed.org).

Corporate-Funded. Corporations fund almost all of ALEC's operations. The Center for Media and Democracy reports that 98 percent of ALEC's funding comes from companies like Exxon Mobil, corporate "foundations" like the Charles G. Koch Charitable Foundation, or trade associations like the pharmaceutical industry's PhRMA. Legislators pay dues, which, however, account for less than two percent of the operating expenses. The funds subsidize legislators' trips to ALEC meetings, where they are wined, dined, and handed the model legislation to make law in their state.

Koch Industries (pronounced "coke") is one of the largest privately owned companies in the United States and owns companies involved in refining; pollution control equipment and technologies; minerals; fertilizers; polymers and fibers; commodity trading and services; forest and consumer products; and ranching. Co-owners Charles Koch and David Koch, through their representation on ALEC's governing boards, have considerable influence over ALEC bills and thus shape legislation, particularly in environmental matters and education, that touches every state.

According to Lisa Graves, in *The Nation*, August 1-8, 2011, "the Kochs have a penchant for paying their way out of serious violations and coming out ahead." A Texas ALEC model bill, now law, gives corporations immunity from penalties if they tell regulators about their environmental violations. There are dozens of such ALEC bills that limit environmental regulations in ways that would benefit Koch.

Profits are as much behind ALEC's agenda as ideology, *Nation* reporter John Nichols told *Fresh Air's* Terry Gross. "[ALEC's] goal is the advancement of an agenda that seems to be dictated at almost every turn by multinational corporations. . . . ALEC is very, very active in [the] opening up of areas via privatization for corporations to make more money, particularly in places you might not usually expect, like public education."\*

**Education.** Parents United for Public Schools (www.parentsunited.org) provides an exhaustive list of ALEC-sponsored bills that have undermined K-12 public education, including:

- Promoting voucher programs that drain public schools of resources
- Creating a scheme to deem public schools "educationally bankrupt" to rationalize giving taxpayer dollars to almost completely unregulated private schools, rather than addressing any problems
- Certifying individuals with no education background as teachers—a move that would weaken the quality of education. This policy is one



## PM Kansas City, Missouri vs. the Nuclear Industry

Some Kansas City residents are opposing plans of Centerpoint Zimmer (CPZ) to build a 1.5 million square foot nuclear plant in their city that would provide 85% of the components of U.S. nuclear weapons at a cost of \$673 million. The federal government will lease the site and plant for 20 years after which CPZ will buy it for \$10. The Kansas City Council will issue \$815 million in bond subsidies from urban blight funds to build the complex.

Opponents have questioned the government's need for building more nuclear weapons as the U.S. already possesses 8,500 nuclear weapons: What of the government's commitment to engage in treaties for nuclear disarmament? How does the new plant fits into the administration's pledge to free the world of nuclear weapons? And, why should they be forced to subsidize the U.S. military-industrial complex with their tax dollars?

The city's peace and disarmament community have stepped into the fray and formed a coalition, Kansas City Peace Planters, which has initiated a petition campaign to place a proposition on the November 8, 2011 election ballot that would reject building a plant for weapons and instead support "green energy" technologies.

In June 2011, the U.S. Council of Mayors voted for a resolution instructing the president to join leaders of other nuclear states in implementing UN Secretary-General Ban Ki-Moon's plan for the elimination of all nuclear weapons by 2020. It includes modernization of nuclear weapons.

Archbishop Francis Chullikatt, the Vatican's ambassador to the U.N., in a speech made in Kansas City in July of 2011 said, "Viewed from a legal, political, security and most of all —moral perspective, there is no justification today for the continued maintenance of nuclear weapons." *The Catholic Reporter's* comment was that "The U.S. trudges unheedingly down the nuclear path. Now more than ever we need to attend to the messages of the often marginalized peacemakers in our midst." Actually they aren't so marginalized: Nearly 5,000 signed the petition to reject the nuclear weapons plant.

On August 25th the Kansas City Council voted 12 to one to bar the proposition from the ballot. The petitioners then sued to block Council interference. CPZ and its contractor, the Honeywell Corporation, and its rinds secured a court decision to delay action for years. In response, Peace Planters crafted a new petition that would cut off city funding for the plant.

Whatever the outcome, the struggle itself is hopeful—indicating that many Americans are appalled by the prospect of more nuclear weapons.



## **Stealing from Our Future: Space Militarization**

Native Americans tell the story of how the white man came to be named Wasichu, the fat-taker. "You shall know him as washi-manu, steal-all, or better by the name of fat-taker, wasichu, because he will take the fat of the land. He will eat up everything. . . . This new man is coming, coming to live among you. He will lie, and his lie never ends. He is going to make a dark, black hoop around the world."

Today the fat-taker lives in the White House, the Congress, the Pentagon, and inside the aerospace industry.

The weapons industry wants increases in military spending during the coming year and is blaming the nation's fiscal crisis on "entitlement programs" like Social Security, Medicare, and Medicaid. Social progress in America is being destroyed to fatten the weapons corporations and their rich allies.

Barack Obama has been associated with the Crown family in Chicago, who were majority stockholders in General Dynamics. Once in office, Obama rejected George W. Bush's version of "missile defense" and instead changed course to primarily rely on the version of missile defense that is based on Navy Aegis destroyers, made by General Dynamics at Bath Iron Works in Maine. These ships are outfitted with "missile defense" interceptor missiles that are having the most success in their testing phase. Obama has increased the building and porting of these ships—and is using them to surround Russia and China by deploying them in waters off the coasts of both nations. Thus Obama is recreating the Cold War, as Russia and China are forced to take serious countermeasures. (Missile defense systems are used as the shield to take out a nation's nuclear retaliatory strike after the U.S. has launched a first-strike attack on their nuclear forces.)

Russia has the world's largest supply of natural gas and significant supplies of oil. China has the world's leading economy, and the Pentagon has made the decision that while the U.S. won't be able to compete with China monetarily, if we can encircle it with our military then we can control its access to resources that fuel its economy. China imports 80 percent of its oil on ships via the Yellow Sea. The U.S. is now doubling its military operations in the Asia-Pacific in order to develop the ability to choke off China's shipping lanes—thus the Pentagon believes the U.S. would hold the keys to China's economic engine.

One new port for these Navy Aegis destroyers, with missile offense systems on board, would be in the small fishing and farming village of Gangjeong on Jeju Island in South Korea. Villagers are

fighting to prevent the destruction of their way of life, but Jeju sits at the strategic entryway of the Yellow Sea and would be a prime naval facility in the U.S. effort to surround China's coast.

The U.S. Space Command predicts that because of "corporate globalization" the gap between "haves" and "have-nots" will widen worldwide in coming years. With space "control and domination" in place, the Space Command will become the military arm of the multinational corporations, enabling the U.S. to suppress those who stand against corporate global dominance.

The fat-takers now have a global strategy. Suppress all the people around the world. Lower the standard of living for everyone. Cut social spending and increase profits for the few. Control the people of the world by controlling space. With space "full-spectrum dominance" in place, the military will be able to hear everything, see everything, and target everyone on Earth.

Each October since 2001, the Global Network has organized an international week of protest to stop the militarization of space, called "Keep Space for Peace Week." Groups organize local events in order to build consciousness about space issues and to help create a global movement to deal with the militarization of the heavens.

We are back to the days of kings, queens, lords, and castles protected by knights in shining armor. The time has come for the peasants to organize and revolt. Our children's future depends on it. If we want to stop space militarization and endless war, we must fight for social progress. Guns and butter are no longer possible. It's coming down to one or the other.

## Coalition Against NATO/G8 War & Poverty Agenda

Chicago will host the NATO/G8 summit from May 15-22, 2012. Simultaneously, the U.S.-financed 28-nation military alliance, NATO, is meeting with a summit of the G8 world powers, the main economic council of wealthy nations. The G8 includes the United Kingdom, France, Germany, Italy, Japan, U.S., Canada, and Russia. NATO has been a leading force conducting war on Afghanistan and Libya. Similarly, the G8's austerity measures have been a recipe for poverty across the globe. Acting together—with NATO as the enforcer and G8 as the economic lever—these two entities work to control the distribution of the world's resources.

In response, the Coalition Against NATO/G8 War and Poverty Agenda was formed and gathered in Chicago to organize protests. More than 200 people representing 73 organizations from across the country met this past August to plan major protests to be held on May 15 and May 19, at the beginning and end of the NATO/G8 summit. Twelve activists from Twin Cities organizations participated in the conference, bringing experience gained and lessons learned from organizing protests at the 2008 Republican National Convention in St. Paul.

It is important for the antiwar movement to seize the opportunity of this historic NATO/G8 summit to demand that our public money be used for human needs, not war.

Let's respond to the call to organize Minnesotans to travel to Chicago in May to demand an end to NATO warfare and G-8 enforced poverty. We will march, with tens of thousands of people under the banner: "Jobs, Housing, Healthcare, Education, Pensions, the Environment—Not War!"

What to do right now: Say no to police repression now. Sign a letter to Chicago Mayor Rahm Emmanuel to demand that the City of Chicago grant us permits to rally and march to the NATO/G8 summit, guarantee our civil liberties, guarantee that there will be no spying, infiltration of organizations, or other attacks by the FBI or partner law enforcement agencies.
