# Demonization, War Crimes and the Task of the Antiwar Movement

When U.S. imperialism engages in an attack on any government or movement, it is cowardly to be neutral, and rank betrayal to stand on the same side as the imperialist octopus, which seeks to dominate the world. This has been an ABC for workers' movements and serious antiwar movements for over a century.

Currently, the corporate media in the U.S. and its allies can demonize the leader of a country targeted by the Pentagon to the point that the consequences of using the most deadly weapons against a totally defenseless population are hidden and dismissed. How does this monopoly of ideas impact the antiwar movement in the United States regarding intervention in Syria, and the war against Libya?

Some alleged antiwar groups and even liberal and progressive media unfortunately spend more time cataloguing the real, or alleged, shortcomings of the demonized leader, in the current cases of Bashar al-Assad and Muammar Gadhafi, than rallying people to respond to a criminal intervention and attacks by the U.S. and NATO "great" powers. The influence of this kind of critic coincides with the opinions of U.S. ruling powers. They are like the voices who said "neither NATO nor Milosevic" in 1999, "neither Bush nor Saddam" in 1991 and 2003, and "neither Israel nor Hizbollah" in 2006. This approach played into the warmongers' motives and weakened the antiwar forces.

Thus, it is important to thoroughly answer their arguments and point to the antiwar movement's main tasks.

Since March, NATO forces have carried out more than 20,000 sorties in Libya, hitting 8,000 targets selected by U.S. Military Intelligence and the CIA, killing many civilians, in what is described as implementing a "no-fly zone." No other armed force in history has had the capacity to wreak such havoc, using cruise missiles, bunker busters, drones, depleted uranium and dense inert metal explosive bombs, antipersonnel razor shredding bomblets, and antipersonnel mines.

# What should be the response to this terror?

Whatever one's evaluation of the leadership of a small, underdeveloped country facing U.S. sanctions, sabotage, and assassination attempts, their leaders are not the reason the U.S. is hell-bent on intervening to try to overthrow the Syrian government and is destroying Libya today.

The U.S. and all the old regimes tied to it in the region are trying desperately to manage and contain the social explosion that is shaking the mostly Arab countries from Morocco to Saudi Arabia, highlighted by the tremendous popular revolutions in Tunisia and Egypt. They want to hold this still unfolding mass upheaval in channels where it doesn't threaten neocolonial domination of the region. Replacing the Ba'athist government in Syria with an openly client regime and gaining military bases in Libya—which lies between Egypt and Tunisia —would serve this purpose.

What is also at stake in Libya is that U.S., French, British, and Italian regimes are determined to lay hold of Libya's now well-developed infrastructure of oil refineries, pumping stations, gas lines, ports, and pipelines directly into Europe, as well as billions of dollars in gold reserves, oil reserves—the largest in Africa—and Libya's other rich assets. All of this has been built up over the four decades since the Libyans expelled colonial and neocolonial domination by the U.K. and the U.S.

These imperial powers are especially determined

to stop Libya's assistance in the development of other African countries. Libya planned a United Federation of Africa and backed it with \$90 billion in investment funds. This move toward independence deeply threatens the continued multinational corporate looting of the continent.

### Corporate media sells the war

In preparation for a war of conquest, the role of the corporate media is to endlessly repeat every charge and statement made by the institutions of U.S. power. An almost frenzied level of lies, wild fabrications, racist stereotyping, and ugly caricatures saturates all political discussion.

The corporate media spread the demands that the Pentagon death machine must act in the name of "humanity" in order to "save lives." The war itself is cloaked in neutral terms. Demonization is meant to disorient and put the massive, criminal destruction planned by the U.S. and NATO beyond debate. Enormous pressure is placed on every level of the U.S. population to accept the premise that the targeted country and its leadership are to blame. The attacks are presented as if Assad is the only person who lives in Syria and Gadhafi is the only one who lives in Libya.

As the Libyan people continue to resist, Western media continues to distort this reality. The Libyans have endured more than five months of nonstop aerial assault. More than one million Propaganda from World War II, remixed by Micah Ian Wright. A NATO-instigated coup was portrayed as a popular, mass uprising in Libya. Even some usually liberal and progressive media joined the chorus.




people have held pro-government, anti-NATO rallies in Tripoli. Libya's government has distributed more than 3 million weapons in a country of 6.5 million people to enable them to resist occupation, something no government does if it considers its citizens to be hostile.

### What antiwar forces should do

The response to colonial wars of aggression should be the same as the response to a racist mobilization, a racist lynch mob or a police attack on an oppressed community: Mobilize all possible forces to stand up to the crime and say "no!" Refuse to take part in the orchestrated campaign of vilification that blames the victims.

However difficult it may be, it is essential to reject the racist political onslaught that accompanies the military onslaught on Libya and intervention in

Syria. The responsibility of progressive intellectuals and groups in the United States is to explain the corporate interests behind the latest "humanitarian" war, and never to echo in left terminology the charges made in the corporate media. The antiwar movement must counter media demonization in the midst of a war mobilization and must focus on the outrageous crimes being committed, refusing to accept or give weight to any justification for them.

The good news is that despite an ocean of propaganda, poll after poll has confirmed that from 60 percent to 65 percent of the U.S. population is against the U.S. war on Libya.

### The Cynthia McKinney tour

People were able to begin to build resistance to aggression toward Syria and Libya, as former U.S. Congresswoman Cynthia McKinney engaged them on a 17-city national speaking tour, sponsored by International Action Center. More than 500 people packed the historic Shrine of the Black Madonna in Atlanta's West End community on July 24.

McKinney had risked her life to visit Libya with a U.S. delegation in the midst of the U.S./NATO bombing. She deserves nothing but respect from the movement.

McKinney was first a target of national media condemnation as a young, first-term state representative in the Georgia Assembly, when she dared to speak out against the U.S. war on Iraq. The entire chamber of representatives stood up, turned their backs on her and walked out.

When she was elected to the U.S. Congress, her outspoken opposition to and questioning of the orchestrated national frenzy surrounding the Sept. 11, 2001, attack; her clear opposition to the wars in Afghanistan and Iraq and passage of the North American Free Trade Agreement; her defense of

She spoke about Libya in a talk sponsored by the WAMM Middle East Committee this past July. political prisoners; and her support of the Palestinian people generated reactionary campaigns that poured funds into opposing candidates in her small Georgia congressional district. Again and again the district lines were redrawn in an attempt to disqualify McKinney from the U.S. Congress. But she has earned international acclaim for her candidacy for president on the Green Party ticket, for participation in humanitarian convoys to Gaza and for being jailed by Israel.

It was expected that McKinney's tour would be attacked politically by reactionaries and militarists. What was unfortunate was that some of the "neither Gadhafi nor NATO" people have also criticized her, some saying she must echo the imperialist demand that Gadhafi "must go." Even more arrogant and insensitive are their attacks on the Nation of Islam and Pan-African voices opposing the war, simply because these forces for more than three decades have followed developments in Libya with great interest and enthusiasm.

Whatever one's attitude toward the Libyan or Syrian governments, the worst thing would be for the U.S. and NATO countries to increase their influence in these countries and in the region. Leave it to African, Arab, and especially Syrian and Libyan people to discuss, debate, and decide their own future, without outside interference and U.S./NATO bombs.

The slogans of the antiwar movement should be: No intervention in Syria! Stop the U.S./NATO war on Libya!  $\mathbf{\hat{w}}^{\circ}$

**Corrections July/August 2011 newsletter:** Actual Grand Jury process is as follows: Federal Grand Jurors are selected pursuant to the Federal Jury Selection Act that provides for the random selection of jurors from voter and/or driver license lists subject to specified qualifications. In a criminal trial, if a witness who is called by the prosecution has testified before the grand jury that indicted the witness, a transcript of testimony the witness gave before the grand jury would normally be furnished to the defendant's attorney. Among the exceptions to this rule that cause the greatest concern arise when the witness is a government agent and the prosecution claims that revealing the full testimony would affect government security.

PM Greed

The enormous 2011 military budget of \$733 billion is not helping the U.S. prosper or even maintain well. Look at the facts provided in one of the informative cards of the Inter-Faith Peacemakers of Edina. Here is how the U.S. ranks in the industrialized world: 25th in infant mortality, 37th in overall health care, and 17th in life expectancy. It has the highest rate of childhood poverty and is the only industrialized country without universal health care. The \$170 billion for the wars in Iraq and Afghanistan could have provided, for one year: 2.6 million elementary school teachers or 22.3 million Head Start slots for children or three million firefighters.

At the present time there is no country in the world that can seriously threaten the United States militarily. But there is growing enmity against our country for its interference in the internal affairs of other countries. Interference may take the form of military force or, when countries experience natural or man-made disasters, it may take the form of aid. If they receive aid a country's leaders find that there will be a price of some kind to pay—it may be the establishment of a U.S. military base, or it may be a trade or other policy that will have a detrimental effect on their country's economy and independence.

The corporations that determine U.S. policy to a great extent are especially interested in obtaining resources. Those resources could be oil, natural gas, lumber, minerals, and/or cheap labor unhampered by U.S. minimum wage standards and trade unions. They also want markets for U.S. products. At one time in the Philippines it was cheaper to buy chicken imported from the U.S. than raised locally. Countries that had been growing beans and corn for their own local markets are instead now growing flowers or soybeans for corporate interests in the U.S. and elsewhere.

These kinds of changes in economies caused huge numbers of people in other countries to leave their homes in search of employment. The North America Free Trade Agreement (NAFTA), signed by President Clinton in 1993, brought devastation to many Mexicans, who for years became immigrants hoping to find work in the United States—the country whose policies contributed to their own country's economic downfall. In the struggle to survive, so many of these immigrants were forced to become underpaid, unprotected, and exploited workers. However, this July 5, many years later, the *New York Times* reported that a growing body of evidence suggests Mexicans are staying in Mexico due to a mix of developments, including expanding economic and educational opportunities there and a slowdown here in the United States as our economic situation declines.

But U.S. corporations continue their predatory quests around the world. There are approximately 268 U.S. embassies and consulates worldwide. Many of them have commercial attachés who promote the economic interests of U.S. corporations with little consideration as to their effect upon local economies or on workers in the U.S. The irony is that as the corporations, and the military that protects them, expand beyond the U.S., our ability to live with material comfort and even a sustainable infrastructure is increasingly threatened. Unemployment rates increase and purchasing power declines.

If the United States could envision its role as that of sharing its technology and know-how instead of acting as a wealthy predator feeding on the resources, cheap labor, and land of other nations, I believe it could greatly reduce its military presence and enjoy genuine friendship from the peoples of the world. Instead of creating justifiable anger and resentment, we could share our knowledge and wealth and learn to be a good neighbor.

# Freedom Flotilla II: A Successful Failure

I woke up Sunday, July 3, to the news that the European Union (EU) had approved Greece's bailout. Greece, in a deep financial crisis, had coincidentally been preventing several of the ships of the Freedom Flotilla II from leaving the Greek ports where they were docked, ready to depart for the Gaza Strip, in an attempt to break the fouryear siege. Greece had used different ploys to prevent the ships from sailing, first claiming that they were not seaworthy, and finally arresting the captain of the U.S. ship. (He was later released without charges.) Only one small ship had been able to set sail for Gaza, and it had departed from a port outside of Greece.

I despaired at the news that the Greek bailout had been approved. Even though it seemed clear that Israel was calling the shots,<sup>1</sup> and that the International Monetary Fund (IMF), the EU, and even individual governments all seemed to obey Israel's orders, the announcement seemed to be a message directed specifically to international Palestine solidarity activists. The message was: "You who dare to go up against Israel, see how we always win? You may have growing numbers, but we have all governments on our side. We will continue to have our way; we will continue to act with impunity, and there is nothing that you can do to stop us."

The history does indeed indicate that Israel always wins: In 2006, in an election deemed free and fair by international observers, Palestinians in the Israeli-occupied territories had overwhelmingly elected the political party Hamas, and rejected the Fatah party. Fatah had been widely seen as corrupt and collaborationist, while Hamas had set up infrastructure, food distribution, orphanages, and schools. Ironically, even though Israel, itself, had played an important part in the genesis of Hamas (believing that a religiously based political party would be a good balance to the secular Palestine Liberation Organization, the PLO),<sup>2</sup> it would not accept the outcome of the elections. Israel declared Hamas a terrorist organization and would not allow it to be legitimized. After fighting among factions from the two parties, Hamas and Fatah, the major players in Fatah left Gaza and set up headquarters in the Palestinian city of Ramallah, in the Israeli-occupied West Bank.

What followed was that, in an effort to induce Palestinians to reject Hamas, Israel imposed a severe siege on Gaza. Although Israel claims that the siege is legal under international law, it is impossible to come to that conclusion by any even casual reading of the international laws and covenants. For example, the Fourth Geneva Convention clearly spells out that civilians are to be protected by an occupying power. Because Israel controls all the borders, the sea and air space, imports, exports, and commerce, and conducts frequent military incursions and extrajudicial killings, it is the occupying power—yet none of the Palestinians within Gaza are afforded basic protections.

The siege collectively punishes all Gaza's residents (another violation of the Fourth Geneva Convention) and has resulted in the devastation of Gaza's economy with 45 percent unemployment, loss of fishing and farming rights, 80 percent of residents dependent on humanitarian aid, and a housing crisis<sup>3</sup> (during Operation Cast Lead, the threeweek incursion in December 2008–January 2009, Israel destroyed 11,000 homes, and Gazans were not able to rebuild because Israel prevented sufficient building materials from entering), but this is not a humanitarian disaster. This is intentional on

Israel's part. Dov Weisglass, Israeli government advisor, said in February 2006: "The idea is to put the Palestinians on a diet, but not to make them die of hunger."<sup>4</sup> Israel can thus claim that there is no humanitarian crisis in Gaza and that therefore there is no reason for internationals to "violate Israeli waters." (The flotillas have no intention of entering Israeli waters. According to the Oslo accords of the 1990s, Palestinians have the right to fish within 20 miles off the coast of Gaza, but the Israeli sea blockade effectively restricts this distance to three

miles. However the situation is viewed, ships entering from international waters into Gaza territory are not within Israeli jurisdiction.)

Even without a humanitarian crisis, the siege is crippling. Necessary material goods come in insufficient quantities from Israel, and therefore many are smuggled in through tunnels (which Israel periodically blows up, claiming they are used to transport weapons).

Perhaps the most crippling of the deprivations is the lack of freedom of movement. Israel controls all movement in and out of the Gaza Strip. Many of the 1.5 million residents of Gaza, including students, people seeking medical treatment, and those with spouses in the West Bank, cannot go outside the Strip's 140 square mile area (from north to south, Gaza is about the same distance as St. Paul to Minnetonka, and it is only about 6 miles wide). This restriction of movement is in

violation of the Universal Declaration of Human Rights, Article 13(2), which states that "everyone has the right to leave any country, including his own, and to return to his country."

With these clear violations of human rights and international law, the Gaza Freedom movement was organized to break the siege of Gaza. One year after Operation Cast Lead, the Gaza Freedom March, in which I participated, intended to reach Gaza by land, but was stopped by the Egyptian government. Only former Egyptian President Hosni Mubarak and Israeli Prime Minister Benjamin Netanyahu know what transpired during the talks at that time, but as the recipient of the second largest amount of U.S. military aid in the world, Mubarak, unwilling to put that at risk, did the bidding of Netanyahu. (Incidentally, even now, with the Arab Spring overthrow of the Mubarak regime and the Egyptian people's overwhelming support of the Palestinian cause, the Rafah crossing between Egypt and Gaza, highly touted as opened, seems to be just as tightly shut as previously.)

In 2008, five ships managed to sail to Gaza before Israel stopped further ships, disabling and destroying them and arresting passengers. Far more damaging to Israel than allowing humanitarians to bring in a few meager supplies was the prospect of having international media shine its spotlight on the conditions in Gaza.

And shine they did, though under tragic circumstances, and in spite of Israel's attempts to prevent journalists access. In May 2010, Freedom Flotilla I was the next to set sail. It included six ships with international passengers, and was another attempt to break the siege. This time the results were lethal. Eight Turkish and one U.S. citizen were shot dead when the Israeli navy violently boarded one of the flotilla ships, the Mavi Marmara, in the middle of the night. Very efficiently, the Israeli Defense Forces (IDF) confiscated all video equipment, computers, and cell phones. Only one passenger succeeded in smuggling out one video. Israel made its own video and released that, but passengers dispute that it was taken during the actual attack on the Mavi Marmara.

So, this past summer, when Freedom Flotilla II was prevented from sailing from a Greek port, the pattern appeared the same—yet another country not at liberty to act on the conscience of its citizens.

But it is the citizens, not the governments, that will effect change. The movement for justice is active in the West Bank, Gaza, and around the world, and has gained enormous strength and attention recently. In 2005, Palestinian civil society issued a call for the international community to boycott, divest from, and sanction (BDS) Israel until Israel complies with international law. Using the BDS movement against South African apartheid as a model, the movement against Israeli injustices has taken off, with divestment initiatives at universities and states (including the Minnesota Break the Bonds Campaign) and boycotts against such Israeli exports as Ahava beauty products and Sabra food items, and heavy equipment manufacturer Caterpillar, which makes bulldozers to use specifically for the demolition of Palestinian homes.

In conclusion: Was I right to be initially dispirited by the apparent control that Israel is able to exert over other countries? No. With every solidarity action like the Freedom Flotilla, Israel has to expend enormous energy to counteract it. It is no longer possible to stem the tide of solidarity activists all around the world who are now able to see Israel's actions for what they are-colonialism, apartheid, and oppression. As Israel institutes ever more restrictive, undemocratic laws,<sup>5</sup> more internationals are certain that BDS is the way to compel Israel to comply with international law. Just as the campaign of BDS against the South African apartheid regime was successful in ending that regime, so, too, will the campaign of BDS, coupled with all the other nonviolent measures, be successful in ending Israel's apartheid and its oppression of Palestinians. W




